Coin Details

Max Supply: 100,000,000

Total Supply: 100,000,000

Circulating Supply: 80,000,000

15,000,000 Coins are reserved for the team, to be used for marketing and promotional efforts, including collaborations with influencers. Spending is capped at 250,000 Coins per quarter.

5,000,000 Coins are allocated for community rewards.

Pre-sale Structure:

Important:

- **Q10:** Hold at least 100 PDK for one month.

Dynamic Phase Progression:

For every 1,000 new registrations for the airdrop, the phase (Q) will automatically progress to the next level.

Liquidity Pool (LP)

59,000,000 Coins are allocated to the liquidity pool, The transaction fee is 0.25%, and all fees remain in the market to strengthen the coin.

Roadmap for PDK Coin

Phase 1: Development and Preparation (Q1 2025)

- Creation of the PDK coin with 100 million supplies.
- Selling 20 million via pre-sales.
- Setting up the airdrop system and rules.
- Initializing the liquidity pool with 59 million coins.
- Preparing for marketing efforts with 15 million coins allocated.

Phase 2: Launch and Community Building (Q2 2025)

- Official coin launch and listing on the blockchain.
- First airdrop campaign and social media promotions.
- Community engagement through influencer marketing.
- Monitoring and reinforcing the liquidity pool.

Phase 3: Scaling and Community Rewards (Q3-Q4 2025)

- Quarterly airdrops with increasing requirements (2-3 PDK Coins).
- Rewarding active community members from a dedicated pool.
- Establishing partnerships to expand project adoption.
- Gathering feedback for continuous improvement.

- Integration of NFT features and historical archives on blockchain.
- Global promotion targeting the Kurdish diaspora.
- Expanding coin use cases for payments and cultural projects, Continuous innovation to inspire future generations.
